Prior to HotSauce, Kai co-founded HIP-Ventures, an early-stage venture capital firm, where he mentored numerous start-up technology companies in multiple industries, including internet security, digital archiving, e-commerce, and satellites. His previous entrepreneurial experience includes 2Suggest (acquired in January 2001 by Citibank) and AEM Technology (acquired in 2003 by UMC in Taiwan).

Kai began his career in corporate finance at Pricewaterhousecoopers, after graduating from Emory University. In the transaction services group, he facilitated multiple M&A transactions ranging from \$120M to \$2.6B.

As a hobby, Kai is also an avid real estate investor, and is a partner in Rooftop Investments, an Atlanta based real estate investment company which owns over 230,000 square feet of commercial properties throughout the Southeast United

# **C. Meade Sutterfield**

Entrepreneur, Angel and private equity investor



Meade is an angel and private equity investor in emerging healthcare and process management SaaS with 37 investments over 30 years. He currently serves on the boards for two venture funds and three companies in which he is an investor.

From 1985-1993 he was concurrently a founder and President of PowerFone Inc and Johnson Communications Corporation, both US regional mobile radio carriers that were merged into the roll-up that created nationwide Nextel Communications. In 1984 he was CEO of AllianceWall, and 1980-1984 was in several positions at Kimberly Clark leading to VP & GM of the Industrial Service Division. Meade launched his career at Scientific-Atlanta with 8 jobs leading to general management in Europe and North America from 1974-1980.

Meade received his BEE from Georgia Tech in 1972 and his MBA from Harvard in 1974, both with honors. He attended Georgia Tech on a football scholarship.

Meade is a past Chair of the Alumni Association of the Georgia Institute of Technology. He currently serves on the Institute's Foundation Board, the Advisory Boards for the Electrical Engineering School and the Flashpoint at Georgia Tech Incubator. He was also President of the Harvard Business School (Alumni) Club of Atlanta in 1985. He is the Chair of the Sandy Springs Arts Foundation, which supports public schools and grassroots arts within the city.

He is a past Chair of the Society of International Business Fellows (SIBF) and a Past Chair of the Global Network Foundation (GNF) of SIBF. In 2002, he was one of the founders of the Central Eurasia Leadership Alliance (CELA) and has participated in all 16 academies and attended almost every reunion, resulting in travel to every country in the region. He was also extensively involved in the founding of the related Middle East Leadership Academy (MELA) and the Southeast Asia Leadership Academy (SEALA) and has served many times facilitator.
